**Welcome** – Perricone – Welcome all in attendance and commented that documents were sent to all members via email – 5:07PM

**Membership Due Structure –**

**Motion to increase RMD divisional dues by \$1.00**

**Discussion** Perricone noted that US Ski and Snowboard Assn. would like to know the dues and fee structure for RMD by mid-March.

Mr. Leseur stated that Rocky Mt. Freestyle did not foresee any change in dues for the 2021-22 season.

Perricone remarked that through conversation with Mr. Glueck, that the Special Jumping/ Nordic combined disciplines would not be changing their dues for the 2021-22 season. Also, through conversation with Ms. Nolting, the Alpine discipline will not request any change in RMD dues.

Perricone proposed increasing that the RMD divisional dues by \$1 to create and support the RMD website.

Currently, there is not money allocated to web development and maintenance. Moneys collected beyond the needs of web site expenses could be allocated at the BOD's discretion, towards other needs such as fundraisers and other efforts within RMD.

Alpine Proposal – **Motion** to approve reallocation of funds granted in August 2020 to the new projects as submitted by the Alpine discipline **\$10,000**

Two requests encompass this request- \$5,000 allocated for the U12/14 project and \$5,000 for the U16 project. This motion was made by Roth, Hughes M/S/C

Perricone reminded BOD that any unused money from the GMI projects would be returned to RMD GMI account to be reallocated for the 2021-22 season.

Bechtel commented that this is the time of year when the Golf Committee began organization efforts for the 2020 tournament and offered his support for upcoming golf tournament. Roth will reach out to Epic promise team to look at future event. Also, Sabrina will likely support the planning of the event.
